BUILDING ENVELOPE	Storm Windows and Doors	ENERGY STAR®, Low-E Coating. Meets IECC in combination with the exterior window/door over which it is installed, for the applicable climate zone. On existing building shell only (no additions or new construction).	Secured <sup>(3)(4)</sup>
	Exterior Doors	ENERGY STAR®, R-6.5 minimum fiberglass doors only with weatherstripping and threshold. Any glass must be double-paned, Low-E, and tempered.	Secured <sup>(3)(4)</sup>
	Air Sealing	Air infiltration levels must be measured by a blower door before & after improvements. Mechanical ventilation must be recommended if air changes / hour are below 0.35 NACH. Performed to at least local code requirements.	Unsecured <sup>(2)</sup>
	Exterior Windows <sup>(1)</sup> and Glass Doors	ENERGY STAR®, U Value: <= 0.30, Low-E glass. Garages and other non-living areas do not qualify unless they are part of the home's conditioned space.	Secured <sup>(3)(4)</sup>

	Solar Light Tube	ENERGY STAR®, U-factor <= 0.55	Unsecured <sup>(2)(4)</sup>
	Ceiling/Attic Insulation	R-49 minimum required in open attic; cathedral ceilings will vary with rafter depth. Must perform air sealing in attics prior to adding insulation.	Unsecured <sup>(2)(4)</sup>
	Wall Insulation	Compliant with International Energy Conservation Code - varies by climate zone. For framed walls R-19 minimum: fill wall cavity where R-19 is not possible. For solid walls such as brick or concrete, exterior rigid insulation must be added to a level of R-10 or higher.	Unsecured <sup>(2)(4)</sup>
	Foundation (Crawl Space or Basement) Insulation & Air Sealing	Crawlspace as outlined in the 2012 IECC. R-15 continuous or R-19 cavity insulation with a vapor permeable air barrier over insulation. Cool/Reflective/PV Roof	Cool Roof Rating Council rated roof materials with an Initial Solar Reflectance Index (SRI) of ≥ 75 for low-slope, ≥ 20 for steep-slope roofs, Solar PV roof tiles, or energy star rated roofing materials. Roofing requests must be reviewed by Clean Energy CU prior to approval. RESIDENTIAL SOLAR & BATTERIES	Solar photovoltaics (PV) / solar electricity (Outside of our registered dealer program)	For an unsecured loan, these types of projects may qualify: (1) "do-it-yourself" solar PV projects (i.e. self-installing the equipment or self-managing a project that includes multiple contractors under your supervision); (2) community solar garden subscriptions; and (3) solar PV roof tiles (which are not eligible for secured loans even if installed by a Registered Dealer)." Minimum/Maximum Loan Size, Unsecured Loans = \$1,000/\$50,000

(3) For secured loans, a Uniform Commercial Code (UCC) form will be filed at both the State and County level.

Minimum/Maximum Loan Size, Secured Loans = \$3,000/\$50,000

(4) Federal and local programs may have different eligibility requirements to receive rebates or tax credits. Please consult with a tax professional to ensure you are eligible for rebates and tax credits.

(5) We require that a solar PV projects be installed by one of our Registered Dealers in order to be eligible for a secured loan.
